Officers of the Department of State and U.S. Embassies and Consulates abroad are prohibited by federal regulation from acting as agents, attorneys or in a fiduciary capacity on behalf of U.S. citizens in private legal disputes abroad. (22 CFR 92.81; 10.735-206(a)(7); 72.41; 71.5.)

This list is updated triennially and includes lawyers who handle criminal and civil (inheritance, divorce, etc.) cases. A separate list of lawyers specializing in business law is available from the Embassy's Commercial Section.

You may obtain additional information about the individuals on the list by contacting the local bar association (or its equivalent) or the local licensing authorities.

- When selecting an attorney, please consider whether you can easily communicate with the attorney and whether he/she appears responsive.
- Please ensure that you and your attorney agree on the services that will be provided for the fee you pay. Normally, this is done with a written fee agreement. It is wise to keep thorough records and receipts of all payments.
- Be prepared for a lengthy process: Greek courts are very backlogged, and postponements and delays are common. Estate and property case hearings may take months or years to schedule. Even criminal cases can take up to 18 months to come to trial. If there are special circumstances, your attorney can petition the court for an earlier trial or hearing date, but such requests are frequently refused.

- The decision of the lower court is often appealed in Greece. In civil cases, however, an appeal cannot be filed until the initial decision is formally recorded by the court, a process that may take additional months. The Embassy has no standing to intervene in these processes.
